### TECHNICAL COURSES

#### ORGANIZATION

The aim of the Technical Courses is to achieve the technical study of historic textiles.

There are several weaving techniques. It is impossible to study all of them in two sessions. The question is more **to acquire a method of analysis** as illustrated in the Technical Dossier, to master the terms defined in the French Vocabulary of the CIETA and **to learn how to represent the various weaves** by means of conventional weave-diagrams.

Persons taking part in the sessions should be able to pursue independent studies, given practice, referring when appropriate to the samples analysed during the sessions.

A complete Course comprises two sessions of two weeks each, with an interval of one year: a two week session in April or in September in the first year, followed by another two weeks in April or September of the next year.

**The first session** deals with plain textiles and provides an introduction to the principles of figured weaving on the shafts loom and on the draw loom.

**The second session** proceeds to more advanced study of historic figured textiles. This second part of the Courses can only be fully understood after following the first part and assimilating the method and the Vocabulary presented therein.

**Classes are in French.** A good level in this language is required.

**Registration:** Request for admission to the Technical Courses must be sent in writing to the CIETA Secretariat. The CIETA Technical Courses are open both to members of CIETA and to suitably qualified non-members. Members and non-members are asked to submit, with their application, a curriculum vitae justifying the validity of their request.

#### FEES

For non-members of CIETA:

- 1 000.00 € for non-member institutions (Course fees paid by an institution, a museum or a company).
- 500.00 € for individual non-members of CIETA (special price granted only for a personal settlement of the Course fees that cannot be reimbursed by an institution, museum or company).

For members of CIETA:

- 715.00 € for institutional members of CIETA.
- 365.00 € for individual members of CIETA and for students (on production of a certificate from the teaching establishment attended).

These fees are subject to revision.

### GENERAL SALES CONDITIONS

#### **Article 1: Sale offers**

At any given time the CIETA site makes a commercial proposal to sell goods and services which fall under both general and specific sales conditions, and which is not legally considered a permanent offer. The CIETA reserves the right to withdraw any product or service, or to cancel a training session.

#### **Article 2: Orders**

Orders addressed to the CIETA are considered final only after confirmation of the order by the CIETA in one of the following ways: postal mail, e-mail, telephone or fax.

The CIETA reserves the right to cancel or suspend any order emanating from a client with whom there is a litigation regarding payment of a previous order, for as long as the litigious case is not resolved.

The CIETA reserves the right not to record a payment or not to confirm an order for whatever reason.

Completing the order form available on <http://www.cieta-textiles.org> and sending that form to the CIETA entails full and complete acceptance of the present sales conditions, which alone will apply to the contract concluded thereby.

#### **Article 3: Prices-methods of payment-risks transfer**

Prices indicated on the site are final. They include tax and are ruled by French legislation. Transport costs are additional.

Prices may be modified at any moment without prior notice.

Goods must be paid for in euros or in US dollars, by cheque, postal order or bank transfer. Any bank charges resulting from the payment are chargeable to the client.

Goods delivered remain the property of the CIETA until payment is complete.

#### **Article 4: Invoice**

The invoice is sent by the CIETA to the address indicated on the order. It is drawn up according to the current tariff at the time the order is made. The CIETA accepts no liability for any errors.

#### **Article 5: Transport and delivery**

Material goods are delivered by post or by an express carrier. Delivery times are given as an indication only. The CIETA cannot be held responsible for transport delays.

Goods must be checked by the client at the time of delivery. Any reservation should be indicated on the delivery docket presented by the carrier or can be addressed directly to the CIETA within 48 hours. Goods should be returned in their original packaging. The CIETA pledges to take back, exchange or reimburse faulty goods, however without obligation to pay damages. Return costs to the CIETA and redelivery to the client are chargeable to the CIETA.

#### **Article 6: Law applicable and jurisdiction**

French law will apply.

Any litigation falls within the sole competence of the Court of Commerce of Lyon, where the CIETA registered offices are located.
